Student Dress Code

All students participating in KYIC 2024 must wear casual business attire.

Student Eligibility

Korea Youth Investment Competition is a competition for high school students, defined as age 14 to 18 international. Students younger than 14 years of age or older than 18 years of age may not participate in this competition. International students or students outside of school may participate in KYIC.

Teams

Teams must consist of a minimum of 4 members and a maximum of 6 members.

Language

KYIC 2024 accepts both Korean and English for report submissions. However, the entirety of the KYIC finals, including presentations and interactions, will be conducted in English.

Round 1 Report Requirements

For round one, teams are required to submit a maximum 10-page report by November 10th, 2024, including:

- A cover page with team, members, and school name
- A client analysis section
- Your team's investing strategy
- 3-4 companies the team found by using the strategy
 - *Look at specific requirements in client case*
- Works cited page

Round 1 Report Criteria:

Round 2 Presentation

For round two, teams will prepare a 10-minute presentation. **Round two will be held on December 14th, 2024.** Following the presentation, there will be a Q&A session with both judges and the competing teams. More information regarding Round 2 will be sent to qualifying participants.

Round 2 Presentation Criteria:

Client Case

The client case provided was fabricated by the KYIC organizing committee for the purpose of this event. It includes details that would benefit your team if included in your strategy, such as risk tolerance and investing preferences. However, it is advisable for teams to incorporate aspects that are not explicitly mentioned in the client case but show creativity and a deep knowledge of investing.

Stocks/Investments

Students are required to identify 3-4 companies/investments in their report. This does not mean students can only invest in 3-4 companies/investments, but the report should include 3-4 most prominent investments.

KYIC 2024 does not have an approved stock list or stock exchange limitations. However, it is advisable that teams provide sufficient information for their investments, both for the judges and in preparation for Round 2. Students are also permitted to pitch assets other than equities, including bonds, real estate, and more. Note that simply stating "invest in real estate, bonds, etc." is not sufficient, and specific examples must be provided.

Awards

All participants of KYIC will be issued a participation certificate via email. Finalists (round one

winners) will be issued a separate certificate, and the top three teams will be issued a special recognition award.

For KYIC 2024, 1st, 2nd, and 3rd place winners will each be awarded an additional cash prize of \$\\$500,000\$, \$\\$300,000\$, and \$\\$100,000\$, respectively. Prizes for KYIC 2024 have been generously donated by Dunamu Upbit.

Competition Procedure

Round 2 of KYIC 2024 will be held through Zoom. An invitation will be sent to qualifying participants prior to the competition date. Following the 10 minute presentation, participants will receive questions from opposing teams and the judges, the managers would facilitate the transition from presentations to questions. Detailed schedule will be sent to finalists.
